

## **END USER LICENSE AGREEMENT for Phaser-DDL by Dusty Devices**

### **1. License Grants and Purchase:**

**1.1** Demo version license: You may download and use the Software for free. The demo version of the Software is otherwise fully functional, but there is a short mute period every 30 seconds.

**1.2** To purchase a full license and to remove the mute period, visit our web site at <https://dustydevices.com>. The purchased full license is for your personal use only, and you are not allowed to distribute it. The license shall apply to the current and any future versions of the Software.

**1.3** Subject to the terms and conditions of this Agreement, you are granted a limited non-exclusive license to install and use the Software on all your personal computers. This License is not a sale of the Software. Dusty Devices retains title and ownership of the Software. You will not acquire any rights to the Software except as expressly set forth herein.
